QUESTIONNAIRE

EMPLOYEE OR VOLUNTEER BEING CONSIDERED FOR A POSITON HAVING SUPERVISORY AUTHORITY OVER MINORS

Section 5146 of the Public Resources Code of the State of California prohibits the North County Recreation and Park District from hiring a person for employment at, or hiring a volunteer to perform services at, any of its parks, playgrounds or recreational centers used for recreational purposes in a position having supervisory or disciplinary authority over any minor, if the person has been convicted of certain crimes under the California Penal Code.
